
Sir,



The Government of Tripura has been pleased to order that a Law College in private public partnership mode set up at Jirania, West Tripura during the current academic session (2022-23) with the approval of Tripura University vide No. F.TU/DIR.CDC/GDC-Jirania/128/2022 dated 14.09.2022 & Bar Council of India vide No.BCI:D1782:2022 (LE/Std.17.12.2022) dated 26.12.2022 is named as '**Jirania Law College**'. The College has introduced the LLB (3 years) course.


Admission to the course/s will be as per the Rules and Regulation of the affiliating University, reservation of seats will be governed by the latest Reservation Act and Rules of the State Government and as per the Memorandum of Understanding (MOU) signed with the Anandanagar Welfare Society, Howrah, West Bengal operated and managed the College in PPP mode. The academic affairs, examination system, curriculum of the College shall be governed by the instruction of the affiliating University to which it is affiliated to and following the norms of the Bar Council of India and Higher Education Department.

The Principal, teaching and non-teaching staff members would be arranged by Anandanagar Welfare Society, Howrah, West Bengal as per MOU signed and as required. All certificates, communication, assets and liabilities, accounts and administration will be made/maintained in the name of 'Jirania Law College' with immediate effect.
